5 Background

This presentation forms part of the general programme for the Partnerships and Performance Committee, reviewing the work of partners.

6 Discussion

- 6.1 The committee receives presentations from organisations who are either funded by the council, or who play an important part in the life of the borough.
- 6.2 Each presentation gives members an opportunity to learn more about the organisation and its impact on the borough. After the presentation there is a chance to ask questions of the presenter.
- 6.3 If any items of significance arise, members may wish to request a further report from a relevant officer or make a recommendation for action by a policy committee.
- 6.4 Alongside councils, Northamptonshire Police are members of the North Northamptonshire Community Safety Partnership (NNCSP), the newly formed governing body for overseeing community safety in the north of the county. However, the police have always worked closely with the Borough Council of Wellingborough to reduce crime and antisocial behaviour within the borough, and this relationship continues within the new arrangements.
- 6.5 A new policing model was introduced in October 2019 which aims to align policing resources to the NNCSP area, with a defined local policing team structure to support local crime reduction.

- 6.6 The NNCSP has set its priorities as:
- A reduction in serious organised crime, and gang related violence
 - A reduction in domestic and sexual abuse and increased support for victims
 - A reduction in antisocial behavior and hate crime
- Partners work together on these priorities, using a problem-solving, multiagency approach to bring added value to the overall outcomes.

7 Legal powers

- 7.1 The Local Authorities (Alternative Arrangements) (England) Regulations 2001 empower the council to establish one or more overview and scrutiny committees. Whilst the council no longer has a designated overview and scrutiny committee, the Partnerships and Performance Committee has been given the role of reviewing and monitoring the performance of council services and services provided on behalf of the council by external bodies. A local authority may invite persons other than members or officers of the authority to attend meetings of such a committee.
- 7.2 The Crime and Disorder Act 1998 placed a statutory duty on local authorities to work with the police and other partners to reduce crime and disorder in each borough or district.

8 Financial and value for money implications

Joint work with the police helps the council to meet its strategic needs, such as the reduction in numbers of homeless, a reduction in antisocial behaviour and vandalism, whilst effective preventative work can improve lives and avoid costly prosecution cases.

9 Risk analysis

There is a risk that if partnership work is not delivered as intended, outputs will not be met. This is mitigated by regular reviews, and presentations to committee.

10 Implications for resources, stronger and safer communities, and equalities

Strategic partnerships with the police, as well as with the voluntary and community sector, contribute towards the council's priorities, offering support in the community to help individuals and communities to help themselves.
